Dear Parents

Hurlyvale Primary School's Budget Meeting was held on Thursday, 6th November 2025. A big "Thank You" goes out to all the parents that made the effort to attend this very important meeting. The main purpose of this meeting was for the School Governing Body to present, for approval by parents of learners at this school, the 2026 Budget, Proposed School Fees and various other Resolutions pertaining to the financial management of the School as prescribed by the South African Schools Act.

On behalf of the Governing Body, I am pleased to announce that a General Resolution was passed, unanimously accepting the Proposed Budget in its entirety.

Accordingly, the compulsory Grade R & School fees for 2026, have been structured as indicated below:

An annual fee for Grade R of R44 440.00 (forty four thousand four hundred and forty rand) & R28 050.00 (twenty eight thousand and fifty rand) for Grade 1 – 7 per learner is payable.

- For those who would prefer to pay on a monthly basis, the full amount of R44 440.00 for Grade R & R28 050.00 for Grade 1 - 7 will be invoiced in January 2026, which is payable in 11 instalments.
PLEASE NOTE: Monthly fees are payable in advance, therefore an amount of R4 040.00 (four thousand and forty rand) for Grade R & R2 550.00 (two thousand five hundred and fifty rand) for Grade 1 – 7 are payable on 14th January 2026. Thereafter the fees are payable before the 7th of each month, between February and November 2026. By choosing the monthly payment option you are required to pay the set minimum amount of R4 040.00 for Grade R & R2 550.00 for Grade 1 – 7 each and every month with the first payment being made in January and 10 payments thereafter, ending the beginning of November 2026.
- Parents who have sibling learners attending Hurlyvale Primary School from Grade 1 – 7 will receive a once off annual discount of R550.00 (five hundred and fifty rand) per additional sibling learner as detailed below for clarity:
Annual fee 1st learner = R28 050.00/ Sibling 1 = R27 500.00/ Sibling 2 = R27 500/ Sibling 3 = R27 500.00.
At this stage, we unfortunately cannot offer a sibling discount involving a sibling who is in Grade R.
- Early settlement payment in full: For those of you who would prefer to settle the full amount in advance, we are offering a discount of:
 - 5% on all school fees paid in full by the 31st December 2025
 - 4% on all school fees paid in full by the 31st January 2026 and
 - 3% on all school fees paid in full by 27th February 2026.This discount is calculated after the sibling discount is given.
Only payments in full by EFT/Internet payments will receive this discount.
PLEASE NOTE: There is no discount offered for those wishing to pay by Cash or Credit Card.
- Any discount afforded on any of your child/ren's fees that you choose to pay upfront in full, will be debited back to your account should any of your other child/ren's fees that you choose to pay monthly, fall into arrears.

- In terms of the South African Schools Act, school fees are a statutory debt and both parents/guardians are liable to pay fees. The School may enforce this payment by taking legal action to recover any outstanding school fees.
- **IMPORTANT:**
For safety and security reasons, we strongly encourage a cash-free school and urge parents to pay fees directly into the school's bank account by EFT/internet transfer. We also have a debit order system. We have attached the debit order mandate if you wish to pay via this option. For ease of reference, and to ensure that fees are correctly allocated to each learner, we further request that a copy of the Deposit Slip / EFT confirmation, is e-mailed to jboyd@hvps.net. These are to be marked for the attention of Julie Boyd. Please ensure that your child's correct Account Number and Surname are used as a reference on the Deposit and EFT slips. - The following resolution was passed at the AGM. In addition to the once off Capital Projects Levy of R500.00 for Grade R & R1 000.00 for Grade 1 -7 that gets charged on admission, there will be an annual levy of R500.00 per learner per year thereafter. This levy will be invoiced in January of each year and is to be paid into the school fee account as soon as possible. (Please also use your account code and surname).
